## Executive Summary

*This report is provided to all current members (both regular and associate) in accordance with Article VIII of our Bylaws.*

The 9/12 Project of the Lehigh Valley Incorporated (DBA: Lehigh Valley Tea Party) started the year with the goal in mind to be an effective organization that would work with candidates and our local Republican County Offices to Make the Lehigh Valley Great Again.

Throughout the year, we focused and endorsed getting President Donald Trump elected. The 2024 year went fast but obviously CD7 (Congressional District 7) was important to the National Republican Committee as two (2) rallies were held in The Lehigh Valley including on Saturday, April 13, 2024, at the Schnecksville Fire Co. fairgrounds (coordinated by one of LVTP's Board Members) and days before the presidential election returned to the biggest battleground state Tuesday, October 29<sup>th</sup> for an evening rally in Pennsylvania's largest city with a majority Latino population. Both of these rallies were sold out with many being turned away.
